

The green transformation - sustainability and transparency



- EU Sustainable Due Diligence Directive
 - Transparency in the value chain re. human rights, compliance with international environmental and social standards
 - Entire value chain, mandatory for all EU companies with +500 employees
- Corporate Sustainability Reporting Directive (CSRD)
 - Non-financial reporting obligations for all companies ≥ 250 employees
 - Implementing rules are being defined
- Sustainable Finance (EU taxonomy)
 - Link to CSRD
 - Possible problems with banks
- Initiative to ban PFAS

Make sustainable products the norm in the EU Ecodesign Sustainable Product Regulation (ESPR)



- Today: Ecodesign Directive as main instrument for EU circular products
- ➤ ESPR = Extension of the scope of the Ecodesign Directive to ALL products.
- Future: Horizontal Product Directive for the European Single Market
- > First focus: textiles, furniture & ICT
- Mid-long term: also B2B products and services



Goal: Address products along their entire life cycle, key aspects:



Improving the durability, reusability, upgradability and repairability of products



Increasing the recycled content in products while ensuring their performance and safety



Reduction of substances of concern



Enabling remanufacturing and refurbishment





Reduction of the CO2 and environmental footprint



Increasing energy and material efficiency

Exploiting the potential of digitizing product information, including a Digital Product Passport (DPP).

Digital product passport Flagship under the new product regulation



Like:

Decentralized system connected to a
European data room
Based on harmonized standards

Content:

Information/data on the individual product ecodesign requirements

What:

Structured collection of productrelated data with predefined scope and agreed data ownership and access rights, transmitted by a unique identifier



The DPP business case



Tracking of raw materials extraction/production, supporting due diligence efforts



Benefit market surveillance authorities and customs authorities, by making available information they SORO Stefano (GROW) carry out their



Enable manufacturers to create products digital twins, embedding all the information required either by or by customers in B2B transactions



Make available to **public authorities and policy makers** reliable information. Enable to link **incentives** to **sustainability performance**




Tracking the life story of a product, enabling services related to its **remanufacturing**, **reparability**, **second-life**, **recyclability**, new business models



Allow citizens to have access to relevant and verified information related to the characteristics of the products they own or are considering to buy/rent (e.g. using apps able to read the identifier

EU initiatives on sustainable product policy - Assessment



Indirectly affecting mechanical engineering, in the **short term**:


- ESPR:
 - for products that are manufactured, processed and recycled on and with mechanical engineering technologies
 - For products/components used by the mechanical engineering industry and for which ecodesign requirements apply
- DPP -> Transfer of information and its processing in the value chain

Direct impact on mechanical engineering, medium to long term:

- ESPR -> direct circular economy and sustainability requirements for B2B products.
- DPP -> Transparency over the entire life cycle also for B2B products and services so far considered


