


ISC Statistics: National Home Sales - global Fluid Power 2022 (estimated): 53.2 Billion Euro - preliminary

CETOP Statistics: National Home Sales - Europe Fluid Power 2022 (estimated): 16.4 Billion Euro - preliminary








Pneumatics (estimated): 4.5 Billion Euro







Hydraulics and Pneumatics by Products 2022 (estimated) - preliminary







Hydraulics Orders and Sales Forecast 2023/2022 CETOP/ISC Quarterly Trend Survey 1 Quarter 2023






Fluid Power - Development January 2017 - April 2023





11 course recommendation documents



LEVEL 1 This person will perform activities that follow an established procedure. Activities will be recurring and of a short term nature. The reaction to most problems will be to summon help or follow a predefined set of actions.

LEVEL 2 This person will perform a variety of activities and needs understanding of the technical factors involved. The activities may require the interpretation and application of varied and non routine specifications. Activities will involve the use of simple diagnostic checks and ability to make a positive response to deviations. Co-operation with others

in team or work groups may be required.

This person will be involved in a broad and often complex range of activities, often requiring independent decisions to be made on technical matters concerning specifications, resources or processes. Planning of work will be a responsibility as will the finding and rectification of faults. Responsibility for the quality of work undertaken and the required outcomes are also included. LEVEL 3
